Definition of categories of membership

Regular Membership

Regular membership is defined as any firm, partnership or corporation actively engaged in automotive repair and is licensed with the Secretary of State (collision repair only). Any such member may designate a qualified employee, partner or other officer as the member's authorized and designated representative. Such designate shall then assume both rights and responsibilities of the designor's membership. The member must have at least one full-time employee and permanent facilities to perform competent motor vehicle repair maintenance or related services for the general public. Every application accepted for membership must have met all existing local, city and state laws applicable to the facility.

Associate Membership

Any firm, partnership or corporation actively engaged nationally, regionally or locally in supplying goods or services to the automotive repair industry may apply for Associate Membership. Associate Members have voting privileges for election of officers and directors of the Association.

Educational Membership

Any school (high school, college or vocational) or firm specializing in automotive curriculum development may apply for Educational Membership.
